Meeting was called to order at 6:05 pm by President Julie Prentice.

Motion to approve the minutes from the April board meeting was made by Marie C, seconded by Linda C.; motion carried. There was no Treasurer’s report.

Old Business: We have no new information on the club’s endeavor to become non-profit. Diana will check with Duane for a progress report; we will also check with Caroline to see if any of the checks have cleared. It was decided that the first choice for the Tom Lamm seminar would be Novemeber, with October being the 2<sup>nd</sup> choice. We are waiting for a reply from Park & Rec as to our request to be able to supply poop bags at one Rochester park. There was a discussion on new member procedures.
