The meeting was preceded by a short information session for guests/prospective members; topics covered included general information about the club, what is required to become a member, & activities that club members participate in.

Meeting was called to order at 7:25 pm by President Julie Prentice.

**Recording Secretary:** Motion to approve the February meeting minutes was made by Linda C., seconded by Patti W.; motion passed.

**Corresponding Secretary:** Lots of mail has accumulated since our last meeting in February, including a class on disaster response as it pertains to animals, artificial grass for dog owners, & an upcoming obedience match; all mail passed amongst the members present.

**PR Committee:** Julie P. & Steph M. are going to attempt to re-visit the possibility of the RMKC providing baggie stations at area parks. We will lobby for Park & Rec to allow us to start with at least 1 park, along with offering that maintenance & bag replacement will be done by RMKC members.

**New Business:** Caroline B. mentioned that now would be a good time to offer CGC testing; date was set for Tuesday, May 2, with a rain date of May 16. Testing will run from 6:30-8:30 pm outside the 4-H building, with registration stopping at 7:30. Caroline will also offer a microchip clinic at that time.

The proposed slate of officers for 2006-2007 was read, & additional nominations were called for. After no new nominations were made, a motion was made by Diane W., seconded by Marie C., to close nominations; motion carried. The slate of officers will be voted on at the May meeting.

There was discussion about putting together membership packets for new members, which would include a copy of the club Constitution & By-Laws, membership list & calendar of upcoming club events; also, if possible, brochures from the AKC about conformation, obedience, agility, etc. could be included. Patti W. agreed to compile these packets & make sure new members received them.

Motion to adjourn the meeting was made by Caroline B., seconded Steph M.; motion passed. Meeting was adjourned at 8:00 pm.
